

## SUBSTANCE ABUSE & ALCOHOL TRAINING FOR SUPERVISORS

Under the Department of Transportation's new regulation Title 49 CFR Part 382, you MUST provide your Supervisors with alcohol misuse and substance abuse training. We now have available for sale or rent videos that meet the Federal guidelines for one hour of training for recognizing the signs of substance abuse and alcohol misuse. All supervisors and drivers must receive one (1) hour of training on the recognition of the signs of substance abuse. All supervisors of drivers must receive one (1) hour of training on alcohol misuse. Companies with 50 or more drivers had to comply with the DOT's new alcohol and drug testing requirements on January 1, 1995. Companies with less than 50 drivers must begin on January 1, 1996.

The **Recognizing Alcohol Abuse Video** fulfills the DOT requirement for alcohol training for supervisors. The video covers the physical, behavioral, speech and performance indicators of probable alcohol misuse by an employee.

The **Recognizing Drug Abuse Video for Supervisors Video** fulfills the DOT requirements for drug training for supervisors in recognizing signs of drug abuse. This video covers the physical, behavioral, speech and performance indicators of probable drug abuse by an employee.
